MINUTES OF THE PROCEEDINGS/RESOLUTIONS OF THE GOVERNING BODY MEETING OF MUNICIPAL COLLEGE ROURKELA ADOPTED THROUGH CIRCULATION AMONG ITS MEMBERS ON DATED 28.06.2019.

Whereas it has not been possible on part of the college for construction/demarcation of boundary wall even though multiple attempts have been made in the past due to opposition by the local tribal peasants who are cultivating the land allotted in favour of the college by the LAC ,hence this resolution by circulation is adopted by the G.B unanimously to arrive at a peaceful solution on the matter.

AGENDA-1

Construction /completion of College boundary wall along with appropriate drainage system and appointment of DLR peons from among the persons in possession of/cultivating the college land.

RESOLUTION -1

In view of the urgency of the matter on the above it is resolved as follows.

- 01. Peaceful negotiation were made with the persons who are cultivating the college land in question .In consideration of their written request ,four persons ,whose family, namely Mrs Sabitri Toppo, Mrs. Arati Oram, Ms. Shibani Toppo and Mrs Bijo Ekka(Last one is widow of Late Amarnath Oram who had relinquished some land in the past for the boundary wall of the college and he was an NMR employee) who are in possession of/cultivating college demarcated/allotted land, shall be appointed on DLR basis as peons in Municipal College, Rourkela as per the Govt. scheduled rate of wages .On appointment ,they shall relinquish the land under their possession. This will also help the college reduce manpower shortage of peons in the college due to death/superannuation of staff in the past. They shall be paid Labour Rate enhancement declared by Govt. from time to time. Principal shall issue necessary orders to the appointees accordingly. Their payment shall be borne out of +3/General Funds.
- 02. Construction of boundary wall with concertina fencing along with appropriate drainage system shall be initiated immediately after giving them appointment letters.Besides,low height Brick Wall shall be constructed adjacent to Sports Block.
- 03. Principal Municipal College, Rourkela is authorized on behalf of the G.B to call for estimate from Govt. work Executing Agency/ITDA for completion of above work.
- 04. Principal Municipal College, Rourkela is authorized on behalf of the G.B to approve the estimate submitted by agency/ITDA.
- 05. Principal Municipal College, Rourkela is authorized on behalf of the G.B to place order for work and place funds with the agency/ITDA for early completion of work. In view of urgency and time constraints, agency/ITDA shall be requested to take up the work departmentally dividing into smaller units for 5 lakh each so that the work can be completed immediately/within quickest possible time.

- 06. Principal Municipal College, Rourkela is authorized on behalf of the G.B to decide on source of funds to be remitted to executing authority i.e out of +2 ,+3,BBA,Financial Assets or combination of some of them based on the estimate received.
- 07. Principal Municipal College, Rourkela is authorized on behalf of the G.B to communicate the agency for split work in view of urgency/importance of the work to be executed.
- 08. Levelling of earth in order to bring uniformity of college land structure shall be done out of college fund.
